Illegal Immigration #1

Illegal Immigration #2

Gun Control #1

Change the Second Amendment to apply only to those over the age of 18

Yea 48.84% Nay 37.21% Abstain 13.95%

Gun Control #3

In order to control the sale of weapons by both public and private entities, ID cards will be issued to citizens wishing to purchase a firearm. The ID card must be presented in order to make any gun purchase. A citizen must be over the age of 18 in order to apply for an ID Card.

Pipeline Construction

The Atlantic Coast Pipeline should be constructed to provide access to electric power throughout Virginia. This sacrifice by Virginians will benefit the country at large and has been approved by the EPA and promises very little impact to the environment. Statues and Monuments #1

Statues and Monuments #2

Death Penalty #1

The Death Penalty should be used in cases of terrorism, mass murder and in certain cases of rape. Brain scans will be used to make certain that all those sentenced with death are in possession of their faculties and knew what they were doing when the crime was committed. In cases of rape the death penalty will be an option when the convicted person is a serial rapist and the victim(s) agree with the sentence.

Response Votes Yea 67.44% Nay 23.26% Abstain 9.30%

Death Penalty #2

The death penalty should be abolished. The "Eye for an Eye" concept leaves the government with blood on its hands. Science is uncertain and thus it is possible for citizens to be put to death who are not-guilty. The history of racial bias also creates the situation where many people of color may be unfairly killed. We support a restructuring of the criminal justice system to emphasize rehabilitation.

Voting Age Lowered to 16 #1

The voting age in Virginia should not change. 16 year olds are not responsible enough to participate in selecting officials and registering opinions on referenda.

Response Votes Yea 76.74% Nay 18.60% Abstain 4.65%

Voting Age Lowered to 16 #2

The voting age can be lowered to 16 after implementing a comprehensive civic education program that encompasses K-12 education. Once ten years of the civic education program has been completed- the age will be lowered since teens will now have adequate civic knowledge to participate in elections.

Response Votes

Yea 34.88% Nay 55.81% Abstain 9.30%

Raising the Minimum Wage

There should not be a blanket increase in the minimum wage. Localities should provide incentives to businesses for increased training for workers and thus they would be eligible for jobs that paid enough for workers to live on. Localities will also have power over the ability to set the minimum wage for themselves according to their specific economic situations.
